**REQUEST FOR BOARD SEAT APPLICATIONS**

The City of Live Oak, Florida, is currently accepting applications for consideration of appointment by the City Council to Seat Number 5 of the Local Planning Agency. Any person may be considered for appointment as a commissioner of the Agency if he or she resides in the City of Live Oak and is otherwise eligible for such appointment per Land Development Regulations Article III, Section 3.3 and applicable Florida Statutes. This is an appointed, volunteer position which will serve a three (3) year term of office. Persons interested in volunteering for appointment consideration should contact the City of Live Oak, at 416 Howard St. E or by calling (386) 362-2009, to obtain an application for such. A fillable version of the application will also be available on our website, though it still must be printed and signed. Finished applications can be emailed to [cdixon@cityofliveoak.org](mailto:cdixon@cityofliveoak.org) or delivered to the Live Oak Annex at 416 Howard St. E. Applications will be accepted through Friday, January 31, 2025, for qualified applicants to be considered by the City Council at the February 11, 2025, regular meeting at 5:30 P.M., or shortly thereafter.

## **Planning and Zoning Board Serving as the Local Planning Agency for the City of Live Oak Appointed Board Member Eligibility Qualifications**

### **Qualifications to become a Planning and Zoning Board Member are as follows:**

The Agency board of commissioners shall consist of seven (7) residents of the City who shall be appointed by the City Council. Any person may be appointed if he or she resides within the incorporated City Limits of the City of Live Oak, Florida, and is otherwise eligible for such appointment under the Community Planning Act, Chapter 163, Part II, Florida Statutes, as amended; however, *no member of the Agency shall be a paid or elected official or employee of the City, or one as identified in Article II, Section 5(a), Florida Constitution.*

Planning and Zoning Board Members concurrently serve as members of the Local Planning Agency, Board of Adjustment and Historical Preservation agency. Each Board Member shall serve a term of three (3) years at a time upon appointment.

When one of these appointed seats becomes available through a term expiration or vacancy, the City of Live Oak will advertise the availability through the local newspaper for a minimum of three (3) consecutive weeks. During this advertisement period, the City of Live Oak will accept applications submitted by qualifying applicants, to be considered by the City of Live Oak City Council at the next regularly scheduled City Council Meeting, following the aforementioned advertisement period.
