- No signage may be roof mounted or at any point protrude above any roof structure.
- Internal illumination is allowed only in certain zoning districts. *Electronic and LED wall signs are prohibited*.
- Freestanding entrance or wall-tower structures must be no more than 3 ft. from the existing building wall or roof canopy, and visually tied into the building in order to be considered a wall sign (*see Planning Staff*).
- Additional criteria may apply.
